

GAD FOCAL POINT SYSTEM PROFILING FOR FY 2022



BACKGROUND

The Philippine Commission on Women, through Memorandum Circular No. 2022-05, requested all agencies to accomplish the GAD Focal Point System (GFPS) profiling for the fiscal year 2022.

The GFPS members of IOD conducted the GFPS profiling based on the indicators provided by PCW.
